EOI DOCUMENT

1. Introduction

Nature of Work:

1. Operation & Maintenance of PFT at Mekalamandi slaughter house-2 Gandhi Hospital backside-1 no, Bansilalpet-ward(147), Begumpet circle.
2. Operation & Maintenance of PFT at Rocha Bazar-1no, MG Road(Opp.james street PS),Distillery road-1no, Ramgopalpet-ward(148), Begumpet circle.
3. Operation & Maintenance of PFT at Smile dental clinic-1no, American consulate-1no,Begumpet-ward(149),Begumpet circle.
4. Operation & Maintenance of PFT at Nehru Nagar park-1 no , Polytechnic college-1 no, sangeeth junction-1no,Monda market-ward(150), Begumpet circle.

2. Scope of Work

- (a) The PFT should be open from 6AM to 11PM every day and one person available at PFT during this period.
- (b) The commodities like mung, soap and towel should be kept available in the PFT.
- (c) The persons present at the PFT should wear Uniform supplied by GHMC
- (d) Not More than Rs 2/- for Urinals & Rs. 5/- toilets has to be collected from users.
- (e) The inside of PFT & its surroundings should be kept clean & hygiene.

3.Bidding Process

The bidding shall be in two cover system; for the Ten PFTs.

- a. Envelope No: 1 – Technical Bid
- b. Envelope No: 2 – Financial Proposal

Initially only the Technical bid shall be opened in the presence of bidders on the same closing date for submission of tender

The technical bid will be evaluated in a manner as per the terms and conditions mentioned in this document and the bids which do not conform to the specified requirements as listed in the said document will be rejected.

During the Technical evaluation no amendments in the bid shall be permitted

Financial proposal of the technically qualified bidders shall be opened thereafter.

The Bidder can either opt to quote for Paying Royalty (per annum per each cluster) to GHMC based on the Projected income.

Or

Willing to seek Maintenance assistance (per month per each cluster) from GHMC towards its O & M.

The evaluation of bids have to be done based on highest royalty quoted per each cluster may be treated as H1 bidder.

Or

In case the bidder seeks maintenance assistance from GHMC instead of paying Royalty, the lowest price quoted agency may be treated as L1 bidder.

If the Bidder / Agency quote for both the conditions the bid may not be considered for evaluation and may be "disqualified".

PREPARATION / SUBMISSION OF BID

The tender shall be submitted accompanied by prescribed forms and duly signed on each and every page.

The bids should be submitted in Office of the Executive Engineer, o/o of zonal commissioner, secunderabad zone, opposite civil court ,west marredpally, GHMC on or before 16.07.2018 at 4.00 pm personally. postal / courier / online submission of bids will not be entertained.

WITHDRAWAL OF THE TENDER

The bidder will have right to withdraw his quotation only before closing of the tender date.
