## **NOTIFICATION FOR INSTALLATION FOR ANY TIME WATER KIOSK**

Greater Hyderabad Municipal Corporation (GHMC) installed Water Kiosk Any Time Water at different locations in GHMC area (as per list of 10 locations enclosed). Interested Reputed Firms / Companies / Agencies, who have experience in installation of Any Time Water Project on BOOT basis in any State and are able to supply the required quantity of water are requested to participate in this Tender.

The interested Reputed Firms / Companies / Agencies shall submit their offer in the prescribed format on or before 06.04.2022 @ 4.00 PM along with Bid Security of Rs.25000/- DD drawn in favour of the Commissioner, GHMC in the Office of the Superintending Engineer, Secunderabad Zone, GHMC, Zonal Commissioner Office, Secunderabad Zone, West Marredpally, Secunderabad, duly enclosing their relevant credentials viz., (1)ISO Registration,(2) Firm Registration, (3) Similar Nature of Work Experience i.e., the capacity to deliver 5000 to 10000 liters of water per day in any one year of past 5 years in State Govt. / Central Govt. / Govt. Organizations (4) Personal Profiles (5) GST Registration No. & (6) Other relevant details.

### **SCOPE OF SERVICES**

- a. The Agency shall install Water Kiosk in the locations selected by GHMC.
  - b. The Agency has to quote its bids, GHMC Zone-wise.
  - c. The Agency shall mention in detail the type of Filtration and its process.
  - d. The proposed Kiosk should have the capacity to deliver 5000-10000 liters per day with expendable slots.
  - e. The expenditure on account of installation & monthly electricity charges, trade license fee, lease rent for the space and other incidental charges to maintain the Water ATM's should be borne by the Agencies.
  - f. Installation & Maintenance period of this BOOT basis shall be for 3 years (Extendable on satisfactory performance)
  - g. The agency should ensure that, the required quantity of water is made available by either HMWS&SB or Borewater (Necessary consent letter from the concerned department has to be provided) at its own cost.
  - h. The size of each unit is not more than 300 sft.
  - i. The agency should ensure supply of quality of water conforming to relevant BIS Standards. Quality Assurance certificate such as ISO Certificate / BIS Certificate or any other certificate is to be obtained and produced with in a period of "6" Months from the date of operation.
  - j. The agency can put up an advertisement showing only the name of the firm on the KIOSK, but the advertisement fee for this has to be paid to the GHMC. However, GHMC logo should be displayed on the advertisement and a clearance to this effect is to be obtained from the advertisement wing of GHMC.

The other conditions are as follows:

1. Trilingual rates should be displayed at conspicuous places & on the units and the rates of potable drinking water are as under.
2. The agency is solely responsible for the quality of water supplied through the Kiosk and for any consequential issues arising out of this sale/consumption of water from this Kiosk.
3. The agreed rates for supply of water to public should not be enhanced and if any increase in rates is noticed the agencies are liable for termination.
4. The agencies should take all precautionary measures for maintaining the Water Kiosk's including quality of water & cleanliness at the respective locations.
5. The agencies should abide by the conditions of GHMC from time to time.
6. The agency is requested to install, commission and operation the Water Kiosk's as per the specifications and standard guidelines in vogue.
7. The officials of GHMC or their representative can visit the Water Kiosk's Plant and check in quality of Water at any time.

The selection of the agency will be done based on the least selling price quoted per litre of treated supplied water.

The GHMC reserves the rights to reject any or all the Expression of Interests (EOI) without assigning any reason thereof, and the firm shall have no cause of action or claim against the GHMC or its officers or Employees or Successors or Assignee for rejection of the offer.
