# 4.1 Mandatory condition from GHMC

- 2. Dedicated Care taker of Rifle shooting range training centre
- 3. Capacity to attend repairs (civil, mechanical or electrical) for the Rifle shooting range training centre including payment of utility bills.
- 4. Should employ Workers for maintenance.
- 5. All the workers should wear covid-19 safety (masks, caps, shoes etc.)
- 6. Should employ certified Coaches for training (with necessary trainer certificates)
- 7. Any other item for maintenance of Rifle shooting range training Shall work in strict supervision by GHMC Executive Engineer, Circle-17 and Sports Inspector, KZ

**4.2 History of litigation and criminal record:** If any criminal cases are pending againsthim/her/ partners at the time of submitting the Bid, the Bid will be summarily rejected. In this respect, the Bidder shall submit an affidavit to the effect that the history of litigation, criminal cases pending against him/her/partners furnished by him/her is true.In case, it is detected at any stage that the affidavit is false, he will abide by the action taken by the GHMC /Telangana State Government without approaching any court whatsoever for redress. He will however, be given suitable opportunity to offer his explanation before action is taken against him

4.3 The Commissioner, GHMC reserves the right either to accept or reject any or all Tenders at any stage without assigning any reasons.

4.4 The Bid submitted without Bid Security will be summarily rejected. The Bid Security of the successful Bidder will be returned when the Bidder has signed the Contract Agreement with the Employer and has furnished the required Performance Guarantee as specified in the document within 7 days from the receipt of the Letter of Acceptance.

- 4.5 The Bid Security will be forfeited:
  - (a) If a Bidder withdraws its bid during the period of bid validity. Or
  - (b) If the Bidder fails to accept the Employer's corrections of arithmetic errors in the Bidder's bid (if any), or
  - (c) If the Successful Bidder fails to sign the contract agreement with the Employer with in the prescribed period, or
  - (d) If the Successful Bidder fails to furnish the Performance Security with in the stipulated time.

4.6 The proposal should be submitted by firms in two parts. The two parts of the proposal are Part 1: Technical Proposal and Part 2: Financial Proposal. For a given Project, Stage -1

of the Evaluation shall consider the evaluation of the Technical Proposal (i.e. Part 1). The firm satisfying the eligibility criteria as mentioned in RFP shall only be considered for further evaluation. Under stage 2, the financial proposal of such firms as selected above shall be opened and evaluated.

4.7 The two parts of the Proposal (Technical proposal and Financial proposal) must be submitted to the O/o Executive Engineer, Circle-17 with all pages numbered serially, along with an index of submission as per procedure undere-tendering. The technical proposal is also required to be submitted in a hard bound form with all pages numbered serially along with an index of submission. The Financial proposal is to be submitted to the O/o Executive Engineer, Circle-17. Submission in any other form shall not be acceptable. In the event, any of the instructions mentioned herein have not been adhered to,the Employer may reject the Proposal.

4.8 **Procedure for Bid Submission:** The bidder shall submit his response to the O/o Executive Engineer, Circle-17.

The bidders shall submit their eligibility and qualification documents, **Technical bid**, **Financial bid** etc., in the standard formats prescribed in the Tender documents, displayed in GHMC web site. The bidder shall sign on the statements, documents, certificates, uploaded by him owing responsibility for their correctness / authenticity.
