Sub: GHMC - F&A Section – Revision of Dearness Relief to the Pensioners from 1st of January, 2022 – Orders issued - To be extended in GHMC – Orders – Issued - Regarding.

ORDER

The Government in G.O.Ms.No.51, Finance (HRM.IV) Department Govt. of Telangana, dated: 19-06-2023 have revised the Dearness Relief from 20.02% of basic pension to 22.75% of basic pension from 1st January, 2022.

Accordingly, in view of the instructions of the Government, orders are hereby issued for revision of Dearness Relief from 20.02% of basic pension to 22.75% of basic pension from 1st January, 2022 to the pensioners of GHMC.

The above revision of Dearness Relief shall be applicable to the employees who retired from service on or after 01.07.2018 and are drawing pension as per the Revised Pay Scales, 2020 and to the employees who retired before 01.07.2018 and whose pension was consolidated as per Government orders issued vide GO Ms. No.4, Finance (HRM.V) Department, Dt: 19-01-2022.

Sanction is also accorded for revision of Dearness Relief to the Pensioners, who are drawing pension in the Revised Pay Scales, 2015 from 55.536% to **59.196% of the basic pension** from 1st January, 2022.

These orders shall be applicable to all the pensioners in receipt of Service Pensions, Family Pensions under Revised Pension Rules, 1951, Andhra Pradesh Liberalized Pension Rules, 1961, Andhra Pradesh Government Servants (Family Pension) Rules, 1964 and Telangana Revised Pension Rules, 1980.

These orders shall be applicable to those drawing family pensions as per Government Orders issued vide G.O.Ms.No.122, Finance (Pen.I) Department, dt: 22.05.2014, G.O.Ms.No.70, Finance (HRM.V) Department, dt:23.10.2020 and G.O.Ms.No.55, Finance (HRM.V) Department, dt:11.06.2021 and to the Pensioners in receipt of compassionate pension under the rules for Compassionate Pensions and Gratuities in the Hyderabad Civil Services Rules.

These orders shall **not** be applicable to Finance Assistance Grantees and others who are not entitled for Dearness Relief.

While calculating the DR, the amount of Dearness Relief shall be rounded off to the next rupee.

The Revised Dearness Relief shall be paid along with the Pension of June, 2023 payable on 1st of July, 2023.



The arrears on account of payment of Dearness Allowance for the period from 1st January, 2022 to 31st May, 2023, orders will be issued separately

Therefore, all the Drawing & Disbursing Officers, Examiner of Accounts and Financial Advisors shall take necessary action accordingly.
